RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

USE OF MOTORCYCLES IS DANGEROUS

Please **read** this notice **carefully**. It affects your legal rights in the use of Ride Area; and in your participation in Activities involving Motorcycles in Riding Areas.

You are **required to sign** this notice and return it to Australian Motorcycle Search and Rescue Inc ("AMSAR") before entering a Ride Area. By signing it, you make each of the statements below as separate representations, acknowledgments, releases and promises. By signing it, you also enter an agreement with the Facilitators, the terms of which are specified below ("the Agreement").

Please note that for the purpose of this Agreement:

- i.* **"Activity (ies)"** means- the operation of or participation in the use of any Motorcycle including preparing, servicing, repairing or testing; or participation in any capacity in any event, organised or unorganised involving Motorcycles; or doing any other thing in connection with a Motorcycle or the use of a Motorcycle; or observing, assisting in or attempting to do any of the activities listed above.
- ii.* **"Facilitator(s)"** means AMSAR; the owner(s), occupier(s) and/or manager(s) of the Ride Area and any organiser(s) of the Activities in the Ride Area and includes their members, guests, instructors, officials, volunteer workers, promoters, sponsors and all persons acting as their agents, servants or persons otherwise acting with the owners', occupiers', managers' or organisers' authority or any of them.
- iii.* **"Ride Area"** means the area that is being used , which requires special authorization, credentials, or permission to enter and includes, but is not restricted to, any area to which admission by the public is restricted or prohibited, and which at the time of use liability could arise or would have arisen if not for this Agreement and includes all hazards and obstacles (whether natural or man made) that are included in that area from time to time; and
- iv.* **"Motorcycle"** means any registered self-propelled vehicle, which is designed to travel on wheels or tracks in contact with the ground, which is designed for use, both on and off road and which is generally and commonly used to transport persons for commuting, recreational, sporting or competitive purposes including without limitation any registered road bike, dirt bike, trail bike, adventure motorcycle, tricycle, sidecar, all terrain vehicle, quad bike, snowmobile and any other registered type of motorcycle.

AGREEMENT TERMS

- a) I am aware that the Activities are dangerous. I acknowledge that the risks associated with Activities in a Ride Area may be increased due to the presence of other uses, of man made and natural hazards and of wildlife and farming livestock. I agree that by undertaking the Activities in a Ride Area, I do so at my own risk.
- b) I warrant that the Motorcycle(s) I will use in the Ride Area is registered and meets the requirements of the relevant state transport act and the relevant state transport regulation(s), is safe and is capable of being used in the Area without risk of harm to myself or to any other person.
- c) To the extent permitted by law, I unconditionally and irrevocably release and absolve the Facilitators from all liability, including all damages, costs, expenses and loss of any nature whatsoever (whether to person or property) ("Liability") in connection with any negligent act, breach of duty, default or omission by the Facilitators or any other person engaging in any Activity in the Ride Area or using the Ride Area.
- d) Furthermore, in consideration for the right to engage in an Activity in the Ride Area, I promise that to the extent permitted by law, I will not claim against or otherwise hold liable any of the Facilitators for any Liability which might arise in connection with any negligent act, breach of duty, default or omission by the Facilitators or any other person engaging in any Activity in the Ride Area or using the Ride Area. For the purposes of this clause use of the Ride Area includes, but is not limited to any recreational activity or the Activities as defined.
- e) I also acknowledge that any person using the Ride Area or participating in any Activity in the Ride Area does so at their own risk and to the extent permitted by law I release and absolve the Facilitators and any of them for all Liability for such persons' acts or omissions whether negligent or not.
- f) I further indemnify the Facilitators, to the extent permitted by law, against any Liability claimed against or incurred by them, or any of them, in connection with any act, breach of duty, default or omission done, committed or not done by me.

I hereby acknowledge that of my own free will and desire I have made the above representations and releases and have entered this Agreement with the Facilitators for the use of the Ride Area and I have read and understood the above terms.
